“Tool Tag Giveaway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

1. Eligibility: The Tool Tag contest is open to legal residents of Newfoundland & Labrador. Employees of CBS Rentals Limited, advertising and promotion agencies, and immediate family members and/or those living in the same household of Employees are not eligible to participate in the sweepstakes or win.

2. Agreement to Rules: By participating, the entrant agrees to be fully unconditionally bound by these rules, and you represent and warrant that you meet the eligibility requirements. (Step 2) Share a Photo: Entrants must share a photo in the comment section of the contest post of their latest project or favorite CBS tool.

(Step 3) Tag CBS Rentals: On the contest post, Entrants must tag CBS Rentals in the comment section.

Once all three steps are completed, Entrants will be eligible to enter the contest. The Entrant will receive one (1) entry into the Sweepstakes. All entries must be received by 5:00:00 pm (NST) on February 29th, 2024. There is a limit of one (1) entry per Entrant for the entire Sweepstakes Period.

All three (3) steps outlined above are required to enter the Sweepstakes and be eligible to win the prize. Entries that are incomplete or do not adhere to the rules and regulations may be disqualified at the sole discretion of CBS Rentals Limited. If there is any attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of CBS Rentals Limited.
